A. CALL TO ORDER

The Called Meeting of Saluda County Council was called to order by Chairman Jerry Strawbridge at 4:00 P.M.

B. <u>INVOCATION</u>

Coun. Daniel delivered the invocation.

C. PLEDGE OF ALLEGIANCE

Chm. Strawbridge led the Pledge of Allegiance.

D. APPROVAL OF AGENDA

On motion of Coun. Butler the agenda was unanimously approved as presented.

E. PUBLIC INFORMATION

It is noted by the Clerk herein that in compliance with the Freedom of Information Act, notice of the called meeting and agenda were given to the local news media and properly posted, to include the county website.

F. NEW BUSINESS

- 1. On motion of Coun. Grice, seconded by Coun. Anderson, First Reading was given on Ordinance No. 11-20, "AN ORDINANCE TO REPEAL SECTION 22-2 COUNTY ROADS; UNIFORM SERVICE CHARGE, IN CHAPTER 22 ROADS AND BRIDGES, ARTICLE I, IN THE CODE OF ORDINANCES SALUDA COUNTY, SOUTH CAROLINA." (Voting in Favor: Chm. Strawbridge, Coun. Anderson, Grice). (Opposed: Coun. Butler, Daniel). During discussion Chm. Strawbridge stated this ordinance was to repeal the ordinance for the \$25.00 vehicle fee. During discussion, Coun. Butler and Coun. Daniel expressed their concerns on repealing the ordinance and both said they were not in favor of the ordinance.
- 2. On motion of Coun. Daniel, seconded by Coun. Grice, it was unanimously approved to accept the revised job descriptions for the Magistrate Clerk, the Civil Court Clerk, and the Deputy Criminal Clerk.
- 3. Chm. Strawbridge discussed with Council that over the past couple months there had been personnel changes and before a department head could advertise for a vacant position, they had to come before Council for approval to fill the position. Chm. Strawbridge said there was currently a hiring freeze in effect and asked for Council's consideration to remove the hiring freeze temporarily and it could be reinstated later.

Chm. Strawbridge asked for a motion to remove the hiring freeze. Coun. Grice made the motion. The motion was seconded by Coun. Anderson. During discussion Coun. Anderson questioned the time frame for removing the hiring freeze temporarily. Chm. Strawbridge asked Council staff for a recommendation. County Director Padget recommended removing the hiring freeze due to no department head had been denied filling a vacant position since the hiring freeze was in effect and it could be reinstated later if needed. Council discussed removing the hiring freeze completely and if needed reinstate it at a later time. The motion to remove the hiring freeze was unanimously approved.

G. ADJOURNMENT

On motion of Coun. Anderson, it was unanimously approved to adjourn the meeting at 4:12 P.M.
