## A. CALL TO ORDER

#### D. APPROVAL OF AGENDA

On motion of Coun. Grice the agenda was unanimously approved as presented.

#### E. APPROVAL OF MINUTES

On motion of Coun. Daniel, seconded by Coun. Grice, the minutes for November, 5, 9, 30 and December 1, 2020, were unanimously approved as written.

## G. REPORT FROM COUNTY COUNCIL CHAIRMAN

Chm. Strawbridge recognized Council Member, Jones P. Butler and Council Member, Wayne E. Grice for their years of dedicated service to the citizens of Saluda County and Saluda County Council and presented them with a plaque of appreciation.

#### H. OLD BUSINESS

1. On motion of Coun. Anderson, seconded by Coun. Grice, and approved, Third Reading was given on Ordinance No. 11-20, "AN ORDINANCE TO REPEAL SECTION 22-2 COUNTY ROADS; UNIFORM SERVICE CHARGE, IN CHAPTER 22 ROADS AND BRIDGES, ARTICLE I, IN THE CODE OF ORDINANCES SALUDA COUNTY, SOUTH CAROLINA." (Voting in Favor: Chm. Strawbridge, Coun. Anderson, Grice). (Opposed: Coun. Butler, Daniel). During discussion Chm. Strawbridge stated this ordinance was to repeal the \$25.00 road maintenance fee to be effective beginning with January 2021 vehicle property tax renewals, and every wheeled and titled vehicle required to be registered and licensed in Saluda County by the South Carolina Department of Transportation, purchased after December 31, 2020.

#### I. NEW BUSINESS

- 1. On motion of Coun. Anderson, seconded by Coun. Grice, it was unanimously approved to adopt the updated Saluda County Personnel Policies and Procedures Manual. During discussion Chm. Strawbridge stated this manual replaced and superseded previous policies, manuals, procedures or other documents relating to employment.
- 2. On motion of Coun. Anderson, seconded by Coun. Butler, and approved, First Reading was given on Ordinance No. 12-20, "AN ORDINANCE TO REPEAL ORDINANCE NO. 3-77, PROHIBITING NEPOTISM OR THE HIRING OF RELATIVES BY SALUDA COUNTY." (Voting in Favor: Chm. Strawbridge, Coun. Anderson, Butler, Daniel). (Opposed: Coun. Grice). During discussion Chm. Strawbridge noted the new nepotism policy was within the adopted Saluda County Personnel Policies and Procedures Manual; therefore the Nepotism Ordinance needed to be repealed.
